CERTIFICATE OF INCORPORATION BY THE SECRETARY OF STATE

WHEREAS, Mrs. Annie R. Brown, 1614 Westridge Circle, Charleston, SC

two or more of the officers or agents appointed to supervise or manage the affairs of

which has been duly and regularly organized, did on the 26th day of
June, A. D. 19 85, file with Secretary of State a written declaration setting forth:

That, at a meeting of the aforesaid organization held pursuant to the by-laws or regulations of the said organization, they were authorized and directed to apply for incorporation.

That, the said organization holds, or desires to hold property in common for Religious, Educational, Social, Fraternal, Charitable or other eleemosynary purpose, or any two or more of said purposes, and is not organized for the purpose of profit or gain to the members, otherwise than is above stated, nor for the insurance of life, health, accident or property; and that three days' notice in the Evening Post, a newspaper published in the County of Charleston, has been given that the aforesaid Declaration would be filed.
